

1 Use of product

Use product for clean and dry indoor vacuum applications under the conditions indicated in chapter «Technical data» only! Other applications are only allowed with the written permission of VAT.

1.1 Technical data

Pressure range extreme UHV to 2 bar (abs)

Differential pressure on the gate 1 bar in either direction

Max. differential pressure at opening 500 mbar, 1 bar with reduced cycle life

Admissible temperature: Valve ≤ 300°C open and closed

 $\begin{array}{ll} \mbox{Manual actuator} & \leq 140\mbox{°C (option } 200\mbox{°C)} \\ \mbox{Position indicator (option)} & \leq 80\mbox{°C or } 200\mbox{°C} \end{array}$

Position indicator: Contact rating ≤ 50 V AC / DC; ≤ 1.2 A (80°C version)

≤ 50 V AC / DC; ≤ 1 A (200°C version)

2 Installation

2.1 Unpacking



Be carefull during opening the boxes and nylon bag, do not contaminate the valve.

Also pay attention that valve and flanges are not damaged when the valve is lifting out of the box and handled afterwards.

2.2 Installation into the system

Remove protection flanges only prior assembly into the vacuum system!

The valve must not support other components and has to be protected from forces of the system (e.g.by bellows sections).



2.3 Connections

2.3.1 Electrical connections (for valves with position indicator)



Do not touch any electrically charged parts!




Electrical power may only be connected if

- valve has been installed into the vacuum system


The suitable sockets are supplied with the valve.

Wiring has to be performed according to the following diagrams:

Position indicators for max. 80°C — contact rating ≤ 50 V AC / DC; ≤ 1.2 A



Position indicators for max. 200°C — contact rating ≤ 50 V AC / DC; ≤ 1 A





3 Operation

3.1 Operation under increased temperature

See «1.1 Technical data»

3.2 Bake out

Valve: ≤ 300°C in open and closed position

Actuator: $\leq 140^{\circ}\text{C (option} \leq 200^{\circ}\text{C)}$

Position indicator (option): ≤ 80°C or ≤ 200°C

Heating and cooling rate: 50°C/h

Operate the valve only after the bake-out temperature has been stable for two hours. If actuation during bake-out is required, the heating and cooling rate from 100°C to 300°C must not exceed 10°C/h.

Temperature differences exceeding 30°C throughout the valve are not allowed. They may affect the performance of the valve.

4 Trouble shooting

Whistling sound during opening/closing: When operating at atmosphere (not recommended):

No reason for concern

When operating at vacuum:

No reason for concern unless the sound gets extensive



5 Maintenance & repairs

Under clean operating conditions, the valve does not require any maintenance during the specified cycle life. Contamination from the process may influence the function and requires more frequent maintenance.

Before carrying out any maintenance or repairs, please contact VAT. It has to be individually decided whether the maintenance/repair can be performed by the customer or has to be carried out by VAT. The fabrication number on the valve



has always to be specified.

All supplies (e. g. compressed air, electrical power) must be disconnected for removal/installation of the valve from/into the system and for maintenance work.



Even with disconnected supply, loaded springs and/or air cushions in cylinders can be potential hazards.




Keep fingers and objects away from the valve opening!




